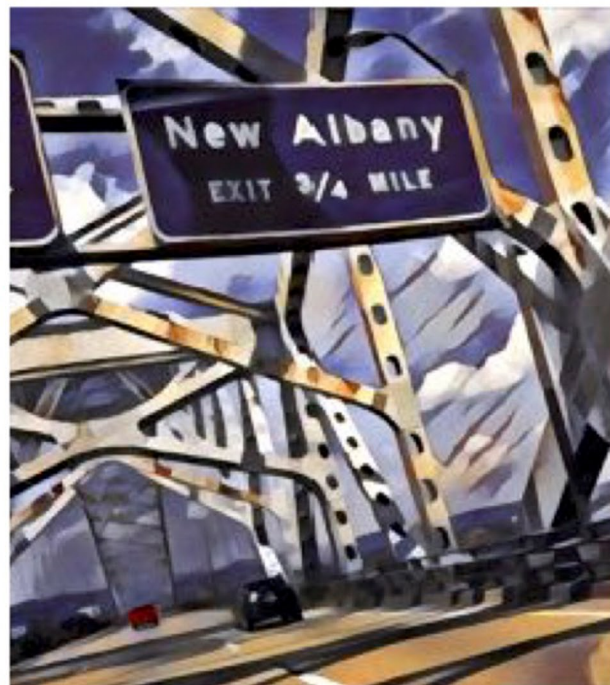




Call For Entries Sewn In Quilt and Fiber Biennial
